# **R7** | Assistance of Undetected Water Leaks Policy 4.19

The Board endorsed a new policy to support customers who have received a high bill after an undetected leak.

Riverina Water has historically provided varying levels of support to customers who have received a large bill due to an undetected leak on an ad-hoc basis.

The Assistance for Undetected Water Leaks Policy provides clarity in what situations Riverina Water can offer support and what type of financial assistance is available.

### R13 | Business Activity Strategic Plan 2022-2032

Riverina Water has developed a draft 10-year Business Activity Strategic Plan (BASP).

The BASP is a local water utility's (LWU's) strategy for implementing the priorities from its 30-year Integrated Water Cycle Management Plan (IWCMP). It ensures that Council aligns itself to the provision of appropriate, affordable, cost-effective and sustainable urban water services that meet community needs and protect public health and the environment.

The BASP is a key strategic tool in Council's overall strategic planning framework and replaces the 2013 BASP.

The draft BASP has been developed having regard to the Community Strategic Plans of our four constituent councils.

The BASP also complies with the NSW Government's Best-Practice Management of Water Supply and Sewerage Guidelines (2007). The plan has informed the drafting of the 2022/24 Delivery Plan and the 2022/23 Operational Plan.

The BASP has established 3 strategic priorities being:

- Our People "we have a high-performance culture, achieved through accountability, diversity, respect and investment in our people"
- Our Business "We strive to be an industry leader by continuously improving our operations and the management of our assets"
- Our Community "We enable our community and customers to thrive by providing exceptional service and demonstrating social responsibility".

These three priorities are underpinned by our three focus areas (or themes) being:

- Customer Centricity We put customers at the heart of everything we do
- Innovation We are a successful organisation that pursues innovation and continuous improvement at all times.
- Sustainability We are environmentally responsible, financially secure and aspire to have a
  positive impact on our natural world

# R14 | Delivery Program 2022/23-2025/26 and Operational Plan 2022-23

Riverina Water's access charge will remain at \$160 per annum for the fourth straight year, while a modest increase in water usage costs has been proposed of 1.5% (about 8\$ increase on a typical yearly residential bill).

The draft Delivery Program 2022/23-2025/26 and Operational Plan 2022/23 are currently on exhibition until 27 May 2022.

The draft documents include an investment of more than \$79M into capital works over the next four years. In 2022-23, there will be \$5.67M spent on mains, services and meters; \$4.83M on treatment plant costs; and \$875,000 on reservoirs.

# R15, 16, 17, 18 | Community Grants Program awarded

More than \$465,000 in funding is flowing to 47 projects thanks to Riverina Water's 2021-22 Community Grants Program.

Clubs, schools, community groups and artists in Wagga Wagga City, Lockhart Shire, Greater Hume and Federation council areas were awarded funding.

### R22 | Asset Management Plan

Following on from the recent development and adoption of the Integrated Water Cycle Management (IWCM) Strategy, the Asset Management Plan 2022 (AMP) has been developed.

The plan has been developed as a blueprint for the effective operation and maintenance of Riverina Water's physical assets over the 30-year planning period; to ensure continued delivery of supply that meets agreed levels of service at the lowest sustainable cost, while supporting growth.

NSW Public Works Advisory were engaged to facilitate the development of the Asset Management Plan using input from Riverina Water for asset, financial and operational data.

## R23 | Development Servicing Plan for Water Supply

The draft Development Servicing Plan for Water Supply has been placed on public exhibition, with a proposed reduction in charges.

The Development Servicing Charge was frozen in 2021-22 with the fee reducing from \$5053 per Equivalent Tenant to the proposed \$4348 in 2022-23.

### R24 | Henty Sportsground – Water connection upgrade

Riverina Water will contribute \$15,330.50 to Greater Hume Council for the upgrade of the water main supplying the Henty Sportsground.

The existing main is not large enough to service the redeveloped sportsground amenities building and function room at the sportsground. Riverina Water estimated the upgrade works will cost \$30,661, which will be co-funded by Greater Hume and Riverina Water.
