Executive Summary

In accordance with the Local Government Act, 1993, a review of Council's Budget position as at 30 September 2019 has been undertaken and the following is submitted for Councillors consideration.

Report

General Fund

When Council adopted the 2019-2020 Operational Plan Budget in June 2019 Council budgeted for a deficit of \$17,783.00. The Budget Review at 30 September 2019 indicated an estimated **SURPLUS of \$82,996.00** as at 30 June 2020 after taking into account movements in revenue and expenditure for the first quarter.

Financial Assistants Grant (FAGS): the current FAGS allocation for 2019-20 available online by the Australian Government, provide an additional \$102,503 in General Purpose FAGS and an additional \$32,467 in Local Roads FAGS, an overall total of \$134,970 more than Council's adopted budget.

Roads to Recovery (R2R): the current R2R allocation for 2019-20 available online by the Australian Government, provide an additional \$592,592.

Revotes: as resolved at Council August 2019 meeting, below items have been revoted:

•	Administration Offices Development	\$50,000
•	Keys & Padlock System	\$30,000
	Capital Expenditure to be Revoted to 2019-2020	\$80,000

Carry Forwards: these are expenditure items budgeted for in 2018-19, which were not expended in 2018-19 and still require to be expended that are not included in the 2019-20 budget.

•	Environmental Services - LSPS & LEP Review	\$10,000

The total of Revotes and Carry Forwards is \$210,200 to be funded from Reserves.

Other significant adjustments in the first Quarterly Review Budget:

Sewerage Fund

When Council adopted the 2019-2020 Operational Plan Budget in June 2019 Council budgeted for a surplus of \$4,216.00 for the Sewer fund operations. The Budget Review at 30 September 2019 did not have any budget adjustments.
